It is JST Capital, LLC's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to [www.jstcap.com](http://www.jstcap.com) (hereinafter, "us", "we", or "[www.jstcap.com](http://www.jstcap.com)"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website.
